CHALLENGE MET

Thanks to the wonderful response from more than 80 contributors, we have matched the anonymous \$5,000 challenge grant which was donated to RCLC to encourage new and greater contributions.

Now the challenge is to raise the rest of the funds needed to complete these projects.

Your contribution to this campaign will help RCLC:

- build the trail and improve parking and public access at Hearn Gulch
- complete the Gualala Bluff Trail
- build the viewing platform and trail at Cook's Beach
- obtain permits and build the trail down to St. Orres Beach

With your help, RCLC can move quickly to complete these projects and provide public access to four beautiful sites for our residents and visitors to enjoy.

Hearn Gulch

\$10,000 of the funds raised so far will be used to meet matching funds requirements for the state Coastal Conservancy's \$240,000 grant to RCLC to purchase the southern portion of the Hearn Gulch headlands.

This summer, RCLC launched a cam-

paign to raise \$50,000 to complete the

purchase of Hearn Gulch, expand the

Gualala Bluff Trail, and build trails

down to Cook's Beach and St. Orres

Beach. Thanks to our many contribu-

tors, we are well on the way to meet-

ing our campaign goal. To date we

have received more than \$17,000,

which we are already using to make

progress on our four major projects.

RCLC OBJECTIVES

The specific purposes of this corporation include, but are not limited to:

(a) The conservation of lands for recreational, educational, ecological, agricultural, scenic and open space opportunities. Conservation of lands shall be accomplished by acquiring real property or partial interests therein, including conservation easements as defined in California Civil Code Section 815.2, and recording appropriate instruments necessary to protect in perpetuity the physical environment of the area for wildlife, ecological and aesthetic purposes beneficial to the public interest;

(b) To promote, activate and develop public coastal accesses to the ocean, rivers and other natural or scenic features, including developing trails, paths and walkways;

(c) To study, project and develop plans for future needs in respect to public recreational lands, accesses and facilities; (d) To determine open space and conservation needs in the coastal areas of Mendocino and Sonoma counties and to arrange for necessary stewardship and conservation by easements, agreements or other mechanisms;

(e) To publicize local needs of the type mentioned above and to raise funds by public subscriptions, grants or other means as necessary to meet such objectives.

Northern California weather, heedless of the calendar, continues our banana belt summer through September into early October. What a reward, when walking the Bluff Trail in August to witness two river otters playing. Do you wish for a quiet moment? Stroll to the bluff west of Trinks (just north of Sea Cliff). The very generous award received from the Coastal Conservancy continues to grow with matching funds, but this amount must be increased to complete the project. RCLC PROFILE - Lois Lutz

I joined the Board in the spring of 2003 and am currently serving as Secretary. Probably the most important thing I bring to RCLC is my 8 years of experience serving on the Board, and as an officer, of a Land Trust in the Livermore Valley.

Since I was already deeply involved in that Land Trust I was excited to find a Conservancy existing in the Gualala area. My husband Harry, and I finished building a second home here in 1994. Of course we came here because we loved the beauty of the coast, but an unexpected bonus was how quickly we got to know some wonderful people, especially through Hikes for Health, Audubon, and the Native Plant Society. One of the first people we met was Ray Van de Water, and since we were both working on Land Trust Boards it was a natural topic of conversation. I was fascinated with the concept of the Gualala Bluff trail providing public access to a vista largely hidden from the road by buildings. I naturally continued to follow the work of RCLC, but I still had a major commitment to the other Land Trust until my term limit was reached late in 2002. When that time came I was finally convinced that, even though just a part-time resident, I would be able to contribute something of value as a Board Member.

I grew up back on the East coast on Long Island, New York, and in Connecticut. We were always close to the water, enjoying swimming and later on sailing. Family vacations were often to wooded lakes in the mountains. I developed a strong interest in nature, even creating my own nature museum as a child. Mostly I collected bird nests, insects, rocks, and shells, but a live garter snake was one of the attractions for a while until I let it go.

I graduated from Brown University with a major in International Relations.

I had fully intended to go work for the CIA or State Department, but after a summer in Boston where I met my husband, plans changed. Instead of Washington, we ended up moving to California and living in Pleasanton in the Bay Area where we raised our two children and where we still have a home.

During that time I went back to school to earn a teaching credential and that led to 25 years teaching 4th and 5th grades in the Livermore School District. I taught every subject, including science. Field trips to the tidepools, local habitat parks, the Oakland Museum, and weeklong Outdoor Education programs in the Redwoods were great learning experiences and fun for the students.

After retiring from teaching I completed a yearlong Docent training program in Natural Science and Ecology at the Oakland Museum of California. I've enjoyed taking students on tours in the Natural Science Gallery for 10 years now. I love their enthusiasm and I feel I'm making

some small contribution to the future by fostering their appreciation for the natural environment.

Also after retirement, came my appointment by the City of Pleasanton to the Board of the newly formed South Livermore Valley Agricultural Land Trust. It was a wonderful learning experience, not only locally, but also in the opportunity to

get to know the wider land trust community. The South Livermore Trust did have an important advantage over other newly formed trusts. It was able to start out with the funding necessary to pay for staff, lease an office, and set up an endowment. That financial backing enabled us to accomplish a great deal, and it is that experience that drives me to want to help RCLC expand its membership and gain sufficient funding to employ at least one staff person.

Being part of an organization that makes a difference, where you can see the results first hand, is a terribly rewarding experience. I encourage anyone with an interest in land conservation to join with us, learn more about what we do, and help however you're able.
